**STALLION SERVICE CONTRACT**

This contract, dated this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the mare owner and stallion owner.

To the stallion “\_\_\_\_\_”, if the stallion is alive, fit and breeding at stud, under the following terms and conditions.

- FEES:
- a) The mare owner shall pay a stud fee of \$\_\_\_\_\_/Mare; payable to stallion owner **before** mare is bred
  - b) If the mare does not arrive ready to be bred (shoes removed, caslick open, in season, negative intrauterine culture)  
the mare owner shall pay a handling fee of \$10/ day for any additional days necessary to prepare the mare and \$10/day for any days left at Goose Creek Polo after mare is finished being bred
  - c) The mare owner shall pay for any veterinary work (including administering progestin) required to breed the mare once the mare has arrived at Goose Creek Polo

CONDITIONS: Stallions service will be provided only to healthy mares in sound breeding conditions, as determined by a certified veterinarian. If mare is barren, it is required to submit a recent negative intrauterine culture certificate (within 60 days).

RETURN OF SERVICE: The mare owner is entitled to a return service to the stallion in the following circumstances:

- a) If the mare does not settle within 30 days following service and the mare owner submits a veterinarian’s certificate to that effect.
- b) If the mare becomes unfit for breeding, mare owner may substitute another mare. This change must be requested in writing.
- c) Negative intrauterine culture certificate required for return service.
- d) Return service expires one year from date the mare was last bred.

REFUND OF FEES: This contract shall be null and void if the stallion should die or become unfit for service prior to servicing the mare in the present breeding season. In this event breeding fees shall be returned.
